- Home Inspection of Parsonage tabled until Trustee Board has additional members.
- Office Painting approved for Jennifer August to purchase the paint and start.
- South Church Doors locks continue to stick; (Mary Brown) will get a locksmith.
- Welcome Center can we revive working on this project? (Yes)

New Business

- Election of Trustee Chair Motion to elect (Mary Brown) as new Trustee Chair Motion passed.
- Request of Classroom Use the food pantry is requesting use of part of the classroom nearest the pantry for extra stock items. The plan is to purchase six rolling shelve carts that could go in there for storage. Pastor Larry is applying for District Grant to cover cost of the shelving. (Trustees in agreement to allow the usage of the classroom.)
- Crack in the Food Pantry Wall (2nd time) repaired under warranty so no additional cost.
- Water soaked ground near cracked wall after much consultation it was determined that
 the water was coming from the down spout from the eve trough. There is NO drain pipe
 leading from the down spout in the ground to disperse the water, therefore it puddles in the
 corner of the building. (Mary Brown to explore)

- **Church Van oil change** is needed. If synthetic oil used- we can almost double the amount of miles per oil change. The filter would need to be changed, but not the oil. *The cost of the oil is twice as much, but is better lubrication synthetic oil doesn't change viscosity when temperatures change. **(Pastor Larry French)**
- Church Van Windshield there is a crack in the windshield cause unknown. Insurance has a \$500 deductible Pastor Larry will have taken care of. (Pastor Larry French)
- Elevator Inspection has not been completed (approved the cost of \$820).
- Upstairs Bathroom light remodel (Mary Brown and Shari Wesche) to complete.
- Cross in Sanctuary looking into backlighting (Pastor Larry French) to obtain information.
- Sign (out front) looking into electric sign (Pastor Larry French) to contact the city about regulations.
- (Terminex approved) to pay the \$220.00 yearly fee.
- The House across the street from the church and next to the new Dental Office is scheduled to be demolished. Attached to the house is the light for the church parking lot. The church had a contract with the previous Dentist stating he would pay for the electric to the light if his patients could use the parking lot during the week. The location of said house will now become a parking lot for the dental office. The church parking lot is developing a hole and we hope to have an agreement with the Dentist for lighting of the church parking lot and pavement of the damaged area in the parking lot. (Pastor Larry French)
